At least one team member must be 18 years of age. Minors must be accompanied by a parent or guardian, unless this portion of the application is completed and signed by legal parent or guardian.

In consideration of my child participating in the iKon Tailgate Tour, I, the undersigned Parent or Guardian, affirm that my child has permission to compete in the aforementioned Bass fishing tournament. I also represent that I understand the nature of activities and that my child is qualified, in good health, and in proper physical condition to participate. I fully understand that these activities may involve risks of serious bodily injury, including permanent disability, paralysis and death, which may be caused by my Child's own actions, or inactions, those of others participating in the event, the conditions in which the event takes place, or the negligence of the "Releasees" named below; and that there may be other risks either not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for losses, cost, and damages I incur as a result of my Child's participation in the activities.

I hereby release, discharge claims, and release from liability iKon Boats, LCC, its respective owners, employees, contractors and other participants, any sponsors, and, if applicable, owners and lessors of premises on which the activities take place, (each considered one of the "Releasees" herein) from all liability, claims, demands, losses, or damages, on my account caused or alleged to be caused in whole or in part by the negligence of the "Releasees" or otherwise, including negligent rescue operations and future agree that if, despite this release, waiver of liability, and assumption of risk I, or anyone on my behalf, makes a claim against any of the "Releasees," I will indemnify, save, and hold harmless each of the "Releasees" from any loss, liability, damage, or cost, which any may incur as the result of such claim. I also agree and approve that any photographs or video tapes taken by iKon Boats, LLC that include images of my Child will be used solely for iKon Boats, LLC marketing. This document is intended to be as broad and inclusive as is permitted by law. If any provision or part of any provision is held to be invalid or legally unenforceable for any reason, the remainder shall not be affected and shall remain valid and fully enforceable.
